## Medina County All Hazards Advisory Committee Zoom Meeting 11-10-2020

Meeting started at 0958 Hrs.

### Old Business:

Chief Haas stated that Sharon Fire donated an old squad to the All Hazards Team. The title is at the Sharon Administration building and Chief Haas will pick up the title.

This Sunday's (11-15-2020) Swift Water training will be a joint venture with the Wayne County Dive Team at Killbuck Lake west. Starting time is 1300 Hrs. Chief Haas stated that anyone who would like to view the training can come to the Lake.

Chief Haas stated he has not pursued pricing for a winch for the flatbed trailer.

Wally stated that the 2021 training schedule is about 90% complete and will be sending out 2021 Applications on 112-16-2020.
