May 5, 2020

Meeting called to order at 1000 hrs.

The meeting started with discussions with Mike Lyons and Heidi Carroll from the Prosecutor's Office about the Medina County All Hazards Team Contract for Service. Mike Lyons stated the contract has some issues with financial structures with EMA already having a contract. This is about Mutual Aid from the All Hazards Team to those departments who don't have fire personnel on the Team.

Christina stated she will get the Lorain County contract to the Prosecutor's Office for review. There was a lengthy discussion about the contract and their will be future discussions at other All Hazards Advisory Committee meetings.

A motion was made to accept the February 20, 2020 meeting minutes as written. The motion was made by Chief Davis, 2nd by Chief Lindner, No discussion, Approved by all, Motion passed.

Matt Sturgeon discussed the outstanding bills for equipment repairs in an excel spreadsheet.

Wally advised that the 2012 F-550 needed tires, the cost of the Structural Collapse trailer striping/decaling from Fred the Sign Guy and finding Fred working on removing the old decals on the R-5 trailer. Wally also advised with the short comings funds that he will give up most of his 2020 Trench equipment and training budget money for the All Hazards Budget.

Christina Fozio stated to transfer \$3000.00 from the Trench training budget to the All Hazards budget for the striping of the Structural Collapse trailer and other repairs needed. The motion was made by Christina Fozio, 2nd by Chief Erskine, No further discussions, Approved by all, Motion passed.

Chief Haas will take the amended budget to the Fire Chief's Board for approval

Rope training was held this past Sunday (5-3-20) in Montville. Everyone who attended the training (5 Team Members) wore masks, took temperatures and did the 6' social distancing. A discussion with the Health commissioner prior to this training. The training was held outside in front of the bay. Weather was nice.
