### Old Business:

The Side Scan Sonar is in an installed on the boat. The training for the Sonar is scheduled.

### 2020 Budget:

Chief Haas explained to Colleen Swedyk that the Budget requests always start early in July. The requests are given to Chief Haas for review, then to the AHAC Board for approval. From here it is approved by the Executive Board and the to the Commissioners Office for final approval by October.

The Swift Water suits on the 2020 Budget are for Law Enforcement Team members. It was stated that 8 of the Sheriff's Deputies are interested in Swift Water.

Bob Bures withdrew \$1,200.00 from the Fire Investigation Unit's account and had given the check to EMA for deposit.

A brief discussion about the Drone Budget and it was stated that it will fall under the Homeland Security Grant which will possibly be out in October.

### Structural Collapse:

Wally stated that Chief Disbrow received a quote from United Trailer Inc. in Indiana to replace the doors on the SCO trailer. The quote is for \$2,272.00. Auto Trim in Medina quote is for \$3,241.23 to fix the doors and also to stripe the trailer. Chucks Custom quote is for \$2,132.23 to only replace the outer skin of the doors.

A motion was made to contact United Trailer Inc. for door replacement by Christina Fozio, 2<sup>nd</sup> by Chief Painter, No further discussion, Approved by all. Motion passed.

Wally stated he will contact Auto Trim about only doing the striping on the SCO trailer.
