Ben Nau

- We received the following spill report since the last meeting
 - 12/10/18: I-76, Barlow Trucking, 70 gallons of diesel fuel from saddle tank, ERTS contracted.
- One 30-day follow-up report(s) were received
- SERC concurred with the Hazmat Plan update at the last meeting.

Greg Smith

- Greg gave the attached Hazmat Report. Notable Items as follows.
 - Notable items:
 - The Solon conference was 11-2-18 & 11-3-18. Tom did a presentation on railcars.
 - There was decon training at Brunswick Fire with the Brunswick ED's
 - We submitted the typing application for the hazmat team to remain a type II team. Changes in team typing requirements have increased the number of technicians from 15 to 21 for a type II team. Currently we have 13 technicians. Type III requires 15 on the team. Greg has reached out to the chiefs to find more members. There is 3 team members that are waiting for a tech class. The team is working on an MOU with Lorain county. The Wayne county team, who we have an MOU with has folded up.
 - Christina said we have a variety of different disciplines on the All Hazards Team. Since it's not just hazmat is lessens the pool of people who want to do hazmat due to people having other choices. When the team started, there was 25-30, but it was just hazmat back then.

- Sheriff Miller ask what determines the type of team needed for each county. Greg explained that Type III can respond to known chemicals, Type II is unknown chemicals, Type I includes CBRN response. It is an accomplishment for our county to be a type II.

Once Around

- Christina Fozio
 - Concept drawings for the storage building are available to look at. We are focusing on phase one, which is the storage portion of the building.
- Greg Smith
 - In November Medina PD received a call reporting an active shooter in the medical office building. Hospital staff if taught ALICE. Everyone did what they were taught. The staff escaped, barricaded, and prepared to defend themselves. Some people have called it a HOAX. For the hospital employees it was real for 2 hours.
- Sheriff Tom Miller
 - There has been an increase in SWATTING incidents.
 - There has been increased training with churches on dealing with and preventing active shooter incidents.
- Andrew Adgate
 - ODNR has an orphan well program. We currently have 4 wells in Chatham Twp. that are being mitigated under the program. Work will be starting soon.
- Colin Johnson
 - On January 17th the Medina County Health Department is participating in a communicable disease exercise.
- Michelle Sowers
 - Michelle reminded the group that exercise season is approaching. She volunteered to be on the design team.
- Matt Sturgeon
 - Natural Hazards Mitigation plan is still being revised. It will be ready shortly to go out to public review. We will use the LEPC as a body to review it.
- Greg Smith
 - Spoke about the MGT 314 class that Greg & Ben went to in Texas at TEEX. It was a great experience being thrown into the planning P process and working roles you do not normally work.
- Anthony Dattilo
 - Anthony spoke about a contractor who was killed on a job. He was hit by a truck that was backing up. It was an avoidable accident that was caused by compliancy.
- There was group discussion about the dangerous wild animal response plan and recent incidents on the news.
