## Motion to approve September Meeting Minutes made by Mark Albrecht, second by Bob Painter approved by all.

Ben gave the following report.

- Ben showed the updates to the EMA website. Now included is an LEPC Spill
  Reporting page. This page has a form for businesses to fill out to report a spill. This
  will fulfill the requirements in the ORC for 30-minute spill reporting to the LEPC.
- All attendees were given a draft copy of the LEPC compliance and enforcement policy. The basics of this policy were reviewed. It still needs to be review by the prosecutor.
- Ben would like to form a LEPC sub-committee. They will act as the compliance and enforcement subcommittee as stated in the compliance and enforcement document. Ben ask the LEPC members to think about being on so it could be formed at the next meeting. Greg Smith volunteered to be on the subcommittee.

Bryan Seamour gave the following report on the RNC.

- Planning is behind where it would normally be for this type of event
- The sub-committees have met a few times each
- The security zone has been determined as of this week
- Press will be at the Convention Center, 10,000 expected
- Cleveland PD will cover security at the convention center
- 3,000 police officers from around the county will be used for the event
- 10,000 will be at the science center and rock hall Sunday night for an outdoor event
- 180 hotels have already been fully booked
- Barriers will start going up the week before the conference
- There will be many sanctioned events in and around Cuyahoga county

- They are expecting around 1,000 non sanctioned events around NE Ohio before and during the conference. They could be held anywhere.
- Transportation routes have not been determined yet
- There will be many different command centers
- Around 50,000 attendees are expected at the conference. Protests are a concern.

Mike Salamone ask about the transportation impact's when going to Cleveland, Bryan is not on that committee and did not have any details. Mike also said the Wadsworth hotels are booked.

Motion to approve Resolution 2016-001 for the LEPC-EMA contract made by Mark Albrecht, second by Alliss Strogin, approved by all.

Christina gave the directors report.

- As an agency in 2016 we will be focusing on education and outreach to remind communities about EMA & LEPC.
- We would like to hold many different training this year, for the public, public safety, and elected officials.
- Matt is working on updating the Emergency Operations Plan and will be soliciting members of the community to serve role's in the ECC.
- We have completed the purchase of the house for the FMA buyout on Riverstyx.
   Now we will be using it for training and then move to the demolition phase.

Greg Smith passed around a Teva water shoe that was purchased for HERT members at CCF using Federal grant funds. He said people like them much better then boots. He said he now has 11 HERT members at CCF Brunswick and is going to be holding a HICS class. Greg also had the opportunity to talk to a 3M rep about their aging PAPR's.

Greg Smith gave a hazmat update

- There are 3 new team members. Greg and Matt will be meeting with them to lay out expectations before any money is spent
- The trailer went to the hazmat conference in Nov. They got a lot of complements about how much better it is organized
- There were 2 callouts. One was on 12-4-15 for assessment by officers in Spencer on SR 301. Coolant and oil spilled into a creek from an MVA. Good job by Spencer fire.
- On 12-13-15 Valley City FD got called to Superior Roll Forming for product in a creek.
   Initially nothing was found. They made contact with the caller and found out it was ½ mile into the woods. They found the creek and discovered it was coming from another creek. Source was a break in a containment system for the solution in their product line.

Tom Schear: He introduced himself. He is an intern with Greg at CCF, he is a University of Akron student.

Allice Strogin: Allice said it has been a quiet month for CARE

FBI: The FBI is working on outreach to counties. They would like to get on hazmat notifications. They can respond to Medina County within 30 minutes.

Bob Zehentbauer: The watch desk is now open 0600-2200. Calls that used to go to OSP now go to the watch desk.

Christina Fozio: She added additional information about when EMA would call. She said it would be for something EMA was involved in. Could be to request additional resources, or just for informational purposes.

Wally Sobczyk: The water team had its first meeting. Chuck Stiver is the team leader, Joe Foecking is the assistant team leader. They have not purchased any equipment yet. They are going to start with training first. Chuck is going to start getting people in the water, he has contacted the rec centers to see if they would be able to use them. Chuck is also going to hold a swift water awareness class in February. The technical rescue team should be receiving the coffer dams sometime in March from the Medina County Farm Bureau.

Mark Albrecht: A farm in Spencer has a vac system that could move grain if we need it. He gave Wally the contact information.
