- Spill Reports
 - Ron Fodo gave an overview of 2 of the spills OEPA received
 - Hydraulic oil in Brunswick from a garbage truck
 - 71 @ 203 50 gallons of diesel from a saddle tank
 - Ron also discussed the criteria for spill reports
- Hazmat Update
 - 3 Responses since the last meeting
 - 9/24/22 Diesel Fuel from saddle tank
 - 9/23/22 Tar in ditch
 - 9/20/22 Color Paste inside truck
 - HMEP funded Chlorine Emergencies Class scheduled for December
- Pipeline exercise
 - The SERC approved the NEXUS Pipeline to be “under the plan for exercise purposes”. The letter sent by SERC to Nexus was included in the meeting packet.
- Hazmat Plan Update
 - The updated hazmat plan was completed and reviewed by Michelle from OEMA. There are no recommended changes. She has referred the plan update to the SERC for approval at their next meeting.

 - At the truck stops in Lodi a female was struck by semi a few weeks ago. The semi did not know he hit her.
 - The county jail is over capacity
 - Working with Fire Chiefs and EMA on active shooter planning
- Matt
 - Working on update to Emergency Operations Plan
 - Working on mitigation grant
- Chuck
 - Hazmat physical process has been revised based on the hazmat TAC recommendations
 - Just started All Hazard Team application process for 2023
 - EMA website updated with information for new All Hazard Team members
- Greg
 - Working on bidirectional amplifier for the hospital. PO approved to conduct the site survey.
 - Conducting surge exercise at the hospital on December 9th to increase capacity for low acuity patients. It will be setup in the conference rooms. They can add about 13 surge beds.
- Brent
 - Seeing a lot of respiratory illness. RSV is very bad right now. COVID is still around and is trending up. October averaged 24 cases a day. Seeing some flu patients, 6 hospitalizations, much earlier than we normally see. Working on tabletop exercise for mid-January.
- Ben
 - Ema is assisting with an MCI exercise in Brunswick on Friday. It will be a CO incident at Saint Ambrose school. The entire school will be participating and about 30 kids will be victims.
 - Planning continues for the CISA communications exercise in February. It will be a large tabletop exercise based around a tornado hitting the fairgrounds. CISA is designing and facilitating the exercise.

 - Building renovation drawing has been finalized and is moving along to the next phase.
