Brent

- The Health Departments full scale pod exercise may be canceled due to COVID-19
- We may be doing a pod next week to hand out food at a drive through food bank at community center.
- HD situation report was sent around the room. Much of what is currently being done is pushing out information to partners. The Health Department is receiving lots of calls from businesses.
- Currently there are no positive cases in Medina County. We will be seeing a lot more cases in the near future.
- The Health Department DOC has been activated

• EOC's opened in a very limited capacity. Most health departments have been continuing to work out of their DOC. Ordered PPE is not being shipped, need to look at getting it through local vendors.

Christina

- We are using webEOC to share information with police, fire departments, health department, hospitals. Many events are being canceled. It's a learning process for jurisdictions to learn about SNS, it's not available to give supplies do departments for normal operations. Department's need to work with their vendors. Christina has spent a lot of time working out of the health department for better coordination. We may use CERT and COMMS Unit at the POD.
- We did not get any funding on homeland security grant this year, only typed teams were funded
