Greg Smith gave the hazmat report

- Greg handed out the attached 2015 Year End Report
  - Greg thanked Mike Salamone for allowing us to store the trailer in the building. Some trailers are still being parked outside, locks are frozen which delays response.
  - Lighting is a challenge at the Highway Garage on W. Smith. There is no exterior lighting when hooking up the trailers.
  - Greg thanked EMA for writing grants this year. In 2015 the hazmat team got a new truck, new suits, and lighting.
  - We have completed renovations to the trailers. Matt Payne championed the projects.
  - Training was a major focus last year that members and officers took advantage of.
- Greg said the hazmat team currently has 17 members, 4 are new
- Greg presented the attached list of trainings and incidents so far this year

- Ben presented the final document for the Compliance Enforcement Program. The document which has been approved by the prosecutor was handed out and approved at this meeting.

- Ben spoke about the LEPC Tabletop they are working on for April 30<sup>th</sup>. It is a joint exercise with Summit County. The scenario will be based on the RNC and include a hazmat component.

Matt Sturgeon

- Matt is conducting a hazard analysis directly pertinent to the EOP and the Mitigation Plan.
- The mitigation plan is due for renewal March 2017. It is a long process so we are getting started now. It is a multi-jurisdictional mitigation plan and is required to apply for mitigation grants.

Dave Rickon – MECARS is working on testing the amateur radios at the hospitals. The amateur radios at the hospitals are programmed identical to the one here in the radio room. They will be doing quarterly testing of the radio's.

William Ryan – On Jan 16<sup>th</sup> OSRT was called out for a missing child. The child came home the next morning. They are attending a training with the U.S Coast Guard on inland SAR. On April 23<sup>rd</sup> there will be rope training at Whipps Ledges at Hinckley Reservation.
