Hazmat Update

- The hazmat team is officially a type II team
- The team had 2 calls. There was a phone consult for Westfield FD and Matt responded to an officer callout in Lodi for a trash truck involved in an MVA.

All Hazards Station 1 Update

- At the April 9th executive board meeting the legal notice was approved to advertise the RFQ for an architect. We received one proposal and need to find out from the prosecutor if we should readvertise to obtain additional proposals. This is to remodel of front half of station, add a second floor and remodel the bathrooms.
- EMA been seeking donations for items to use at the station. Tables/chairs were donated by Redwood Apartments. The pallet racking was also donated. Colleen said due to closing a department, there will be many items available if we want them.
- EMA will eventually be completely moving out of the Sheriff's office. Currently we have moved stuff out of the FOC
- EMA is working on a mass casualty/mass fatality plan with a contractor. The full-scale exercise will also be done by the end of the year. The fire chief's association is working on picking new triage tags. This is all funded by two homeland security grants.
