James Bigam called the meeting to order at 0830

Motion to approve January Meeting Minutes made by Mark Albrecht, second by Greg Smith approved by all.

Greg Smith gave hazmat report

- Hazmat report attached to minutes
- There have been 2 callouts since the last meeting
  - On 6/25 there was a callout for Anhydrous Ammonia leaking from a tank on a farm. It was called in by a passerby who could smell it. The fire department observed a visible vapor and liquid coming from the top of the tank. An entry was made and the valve was turned ¼ turn which stopped the leak. It is unknown why the valve was open.
  - Yesterday 7/6 the team was called to Plum Creek park in Brunswick Hills for oil leaking from a well tank. The oil had spilled into the containment area around the tank and down the access road about 300 feet. Per ODNR the vac truck pulled approximately 25 barrels of oil from the ground and they are ensuring the contractors continue the cleanup. Greg thanked BHFD for the good work containing the spill prior to hazmat's arrival.

## Directors Report – Christina Fozio:

- The demo for 5497 Riverstyx is scheduled for July 11<sup>th</sup> and should take 3 days. The driveway will be removed and the property will be graded and seeded.
- Christina said we received a homeland security grant to support the RNC for radio's and a hazmat ID.
   The hazmat ID was shown and explained to the committee.

#### Christina

- There was a meeting on Friday at Cuyahoga County EMA, Cleveland is sharing limited information. Some of the surrounding County EOC's will be activated for the week.
- Our EOC will be activated from 1200-2000 on Sunday and 0800-2200 Monday Thursday. We will be using webEOC and Knowledge Center for information sharing.
- o Situation Reports will be emailed out to steak holders at 0930, 1530, 2130 each day.
- We will be setting up Everbridge groups incase notifications are needed.
