OLD BUSINESS:

The transportation section of the Debris Management Plan needs evaluated.

Jacqui Russell has been working on the planning and training of Pandemic Flu issues.

There are concerns with the amount of bodies that the Funeral homes in the County could hold, also, lack of coolers and the social distancing issues.

When the new construction is completed at MGH, they will be able to hold 8 bodies.

NEW BUSINESS:

Alan Rickenbrode has resigned as the EMA Hazmat Compliance Officer, and the Executive Board has approved the hiring of Bill Herthneck to replace him. The job is part-time.

In March, the Sheriff is having a 40 hour Terrorism training, to be held in the EMA EOC.

Brunswick is holding a Terrorism course in February that is one day.

The incident to be evaluated for exercise credit occurred on Smith Rd at 3:30pm, 700 gallons of Acetone spilled out of an overturned tanker truck. Buck provided slides of the incident.
