Budget Update: Buck Adams

- Commissioners have allotted \$8,000 to the LEPC.
- The EMA would like to take on the Tier 2 project this year if the hospitals are not interested.

Exercise Update: Buck Adams

- ❖ EMA participation will be on March 18th.
- ❖ Invitations will be going out this week of next (January 29th or the week of February 1st.
- ❖ It will be a functional EOC dealing with snow, ice, wind and an overturned tanker
- Red Cross will be the simulators
- EMA will exercise emergency notification, EOC Operations, Communication, Resource Management, Traffic access and control, and PIO

 - o FEMA has awarded a grant in the amount of \$15,000 for equipment
- Ed (retired) would like to see the members affiliation added with their name on the minutes
- ❖ John (retired) would like to recognize and thank the Medina Co. Health Dept for all their hard work and a successful flu clinic on Brunswick
- ❖ Dave K (Red Cross) Feb. 5th is the Chocolate Fair, and the Red Cross assisted two families after fires destroyed their homes or a portion of.
- Reggie (OEPA) has a handout on the spills in Medina County, and he would like to add spills to the agenda to be more proactive in getting the information to EMA and LEPC
- Don and Jean (MC Health Dept) the Health Dept has given 25,000 vaccinations so far and are now taking appointments (approx 60/day)
 - o They are done with the schools and will be at Job & Family services
- EMA has a new intern from the University of Akron that will be working on and completing a new Hazmat traffic corridor study
