The Medina County LEPC Meeting was called to order at 8:35am.

A motion to approve the March 26, 2009 meeting minutes was made by Ed Schneider, seconded by Mark Albrecht and unanimously approved by all.

## Exercise Discussion:

- Buck explained Jack Snoddy's departure. Everyone is in consensus that the exercise went well and there was a lot learned. There was a discussion about a command box.
- Mike chose to decon 30 people in 2 hours with Zumros, and a separate call tree was established for decon equipment. Some parts went well and others did not.
- > Jacqui said that MGH tested triage in the ED, while Jim Bigam was in the Command Center; things went well.
- Hamm Radio was tested.
- The Red Cross had a shelter in the basement of the Red Cross and may have acquired a Methodist church for future shelter use.
- DAT members were contacted.
- Medina City Fire Chief Bob Painter said it was quiet on the fire side of things.
- Mark Albrecht commented on the activities of the Debris Plan, which went well. They are looking at a separate dump.
- Communication is always a factor and can always be improved.
- ➤ Buck asked that Reggie and Sue say thank you to the Solid Waste participants. The EPA will be invited to the EOC in future exercises.
- Justin and Christina agreed that the field was chaotic at first. The Medina and Wayne County Hazmat teams played well together, and there is a formal MOU with Wayne County for all services.

## **New Business:**

➤ LEPC contract sample from Erie (handout). Buck discussed the change of rules to LEPC's. The EMA wants to contract with the LEPC to make the record keeping for the audit

- simpler. A motion to approve this was made by John Gotheridge and Alliss Strogin. Buck will write the contract.
- ➤ The EMA would like to make record retention simpler by possibly making it electronic. SERC states 1 year on-site and 7 years off-site. We have records from 1989. Buck would like to set up a subcommittee for storage recommendations and write a records retention policy to go the Prosecutor and SERC for adoption. Reggie will look into the State's policy to see if it will work for us.
- ➤ Buck asked Justin to talk on H1N1, and the difference between this and the seasonal flu is that the swine flu is happening in the summer, there is a 2% death rate and 15 known cased in Ohio. The Health Dept is looking towards Sept/Oct to see if there is a second phase and if it is worse (mutates). There was a handout on swine flu.
