- Kurt Kollar discussed his experience with the event. In the video it was clear that the driver was aware of the spill. Mr. Kollar said he told them directly that the spill needed to be reported, and they did not report it until the following day.
- Anthony Dattilo explained that the company needs to respond more quickly.
- Gary Pacheilich said there is not a fundamental disagreement in the facts. There was a disconnect between his client's roadside service department and their risk department. There is no dispute that the 30-minute notification was not made, however it does not seem to be a systemic problem with the company, and the company has updated its internal protocols.
- Anthony Dattilo discussed that ORC 3750 allows a maximum fine of \$25,000 per day, which is \$50,000 for two days.
- Gary Pascheilich spoke about the amount of the fine. He provided justification on why the fine should be less.
- Kurt Kollar said ORC 6111 is related to polluting waters of the State versus ORC 3750 which is related to release reporting.
- Anthony Dattilo asked Gary Pascheilich if his client would agree to a \$10,000 fine. Mr. Pascheilich said he will report it back to his client.
- Julio Esis shared his experiences with negotiating fines in industry.
- Kurt Kollar explained the importance of reporting to minimize the impact of a spill.
- Mark Albrecht said it is total negligence and they should be happy it was reduced to \$19,000.
- Anthony Strazzo said they did nothing until Seville PD contacted them.
- Alliss Strogin discussed that we could have charged them \$29,000. We went down to \$19,000. They should be happy with that.
- Aaron Harrison suggested that we should listen to the weight of the industry in the room. Also, we should revisit our policy if we decide not to follow it.
- Alliss Strogin motioned to except the fine of \$29,000, which died from lack of second.
- Aaron Harrison motioned to accept the sub-committee's recommendation of \$19,000, seconded by Terry Grice. Yes 15 votes, No 1 vote, Abstentions 1 member.
- Mr. Bartoe will draft a Compliance Action Letter to Marten Transport to communicate the decision.
- There was general discussion about the 30-minute release notification.
